SUBJECT: **Agency Director Salary Review**

Pursuant to 74 O.S., Section 3601.2, please be advised that the Office of Management and Enterprise Services Human Capital Management (HCM) Division recently concluded a comprehensive state agency director salary review.

HCM contracted with an independent vendor to examine salaries of all agency directors and compare those salaries to similar positions in the public and private sectors within Oklahoma and elsewhere. Through this review, the appropriate salary range was determined for each state agency; these results are attached in spreadsheet format for your information and review.

Please be aware that this data represents a resource; it is not a directive, nor does it recommend or require any action. Appointing Authorities and agency governing boards should make any determinations on an agency by agency basis. Financial decisions should continue to be made in the best interests of the agency and its mission, and the performance of agency directors should continue to be regularly and rigorously evaluated.
